**Subject : Regarding raise in intake for B.Pharmacy Course from 60 to 100 seats for the academic session 2022-23**

Sir,

Under Chapter-IV, clause 9(ix), Ordinance No. 61 of Himachal Pradesh Technical University and pursuant to the decision of 381 meeting of Executive Committee of the Pharmacy Council of India held on 11.11.2022, and the request / appeal submitted by your institution, the Standing Appeal Committee reconsidered the appeal and hereby recommended to raise in intake from 60 to 100 seats for the academic session 2022-23.

The raise in intake is subject to fulfillment of the deficiencies pointed out by the Expert Visit Committee/Inspection Committee, which is already conveyed to you vide letter No. HimTU-3(Acad)B-6/2016-Vol-III-3056 dated 08.08.2022 and subject to creation of required infrastructure / faculty / facilities including Labs, Class Rooms, Examination Hall as per PCI/HPTU norms.

The above mentioned approval is further subject to the following conditions failing which the process of disaffiliation will be initiated.

- Submission of compliance report in respect of deficiencies along with documentary and affidavit on judicial stamp paper duly signed by the Chairman/Principal of the institution.
- No excess admissions shall be made by the Institution over and above the approved intake by the PCI/HPTU.
- Institution shall not charge tuition and other fees than as prescribed by the Govt. of Himachal Pradesh / HP Technical University.
